Sealed Tender documents (both Technical & Financial Bid) must reach the undersigned at his address, **Prof. Gangadhar, No. 59, III Main, 1 Cross, Income Tax Layout, Vijayanagar, Bangalore- 560 040** on or before **21.02.2019**. The Earnest Money of 2% of the total estimated contract amount to be paid by Account Payee Demand Draft/Cheque in favor of "The Indian Science Congress Association" on any nationalized bank of India payable at Kolkata along with tender documents.

The bids for Six (06) unarmed Security Guard will be for 8 hours shift (02 Nos. for 1st Shift – 0600 hrs to 1400 hrs , 02 Nos. for 2nd Shift – 1400 hrs to 2200 hrs, 02 Nos. for 3rd Shift – 2200 hrs to 0600 hrs) on all days including holidays. The rates should be quoted in accordance with minimum wages Act of the Central/State Govt. & are liable to be increased proportionally if and when the minimum wages are increased by the local government. The contractor has to certify that the Security staffs will be extended all the benefits such as PF, ESI etc. in accordance with relevant Central/State Labor laws. The Security Contractor should be a registered Company/firm holding all required licenses/tax registration documents etc. The contract will be initially for duration of one year from the date of signing of the new contract and may extend up to maximum of three years under same terms and conditions subject to satisfactory performance every year.

The successful bidder will have to execute a contract agreement with the office and the validity of the contract agreement will be for a period of one year which the successful bidder has to convey in writing. EMDs of all other bidders shall be returned on completion of tendering process.
